## New York State Energy Research and Development Authority Climate Action Council

Draft Scoping Plan Comment of:

New York State AFL-CIO

July 1, 2022

The maintenance and creation of good union jobs must be a primary goal of the State's climate action initiatives. Therefore, we strongly support aspects of the Draft Scoping Plan that prioritize workers' rights. However, the Climate Action Council must do more.

The Draft Scoping Plan must be amended to ensure that newly-created jobs are good union jobs; minimize job loss; and ensure that any worker who loses their job because of steps taken to combat climate change is promptly, if not immediately, reemployed at the same rate of pay or greater and with the same, or better, benefits.

As part of the transition, we must ensure that workers' organizing rights are protected. Workers who have chosen a union must keep that union and workers in newly created positions must have the most robust organizing rights and protections we can confer.

These commitments to workers must be included in the Scoping Plan in the most concrete, enforceable terms possible, such as job protections; labor peace agreements; civil service protections; project labor agreements; and Buy New York, and Buy American requirements.

Additionally, the Scoping Plan must ensure a skilled and productive workforce by prioritizing apprenticeships and training; and by identifying revenue streams to fund apprenticeship and training programs.

Further, the Climate Action Council must limit impacts on other industries including manufacturing, smelting, restaurants, and hospitality. The Climate Action Council must also take steps to prevent importation of energy from outside New York, such as eliminating arbitrary dates for closing generation facilities. Facilities must not be shuttered until objective criteria, including reemployment of current workers, are met. Similarly, the plan must anticipate and lessen the impact on municipalities that rely on property tax payments from any facility closed as a result of climate change mitigation efforts.
