# Economywide Subgroup Meeting 1 Notes

#### Meeting Agenda/Topics Covered:

- Overview of the subgroup charge/scope, and workplan
  - O Subgroup members reviewed the subgroup charge/scope, and workplan.
  - o Some members emphasized the importance of the subgroup fulfilling the charge of providing recommendations on economy-wide approaches to the Council.
- Review of Economywide Policies
  - Subgroup reviewed the framework and options for three policies outlined in the Draft Scoping Plan.
    - Policies that impose a price on the emissions of GHG emissions: cap-based policies and carbon tax/fee.
    - Policies that require a regulated fuel category to reduce its carbon footprint: clean energy supply standard.
  - Sector Coverage Under Economywide Policies
    - One subgroup member asked about examples and approaches to applying policies to emissions from hard-to-measure sectors, including waste.
    - Subgroup discussed challenges of monitoring certain emissions sources (e.g., agriculture) and examples of sector-specific legal exemptions (e.g., jet fuel) from cap-based policies.
      - Noted options for delayed phase-in approach for certain sectors and reinvesting funds to reduce emissions in these sectors.
      - Subgroup emphasized the importance of aligning other regulation and programs to target emissions reductions in these sectors.
  - o Clean Energy Supply Standard
    - Some subgroup members asked about examples of jurisdictions applying a clean energy supply standard to buildings.
    - Subgroup discussed approaches and possible examples of implementation in other jurisdictions, which identified Canada's plans to pursue clean energy standard for buildings after fully implementing the standard for the

- transportation sector. The subgroup and State staff were unaware of other states that have a clean energy supply standard for buildings currently.
- Subgroup discussed the opportunity to give credits for heat pump installations in line with existing EV charging credits.
  - Noted for further discussion and consideration by the subgroup.
- Co-Pollutant Reduction in Disadvantaged Communities (DACs)
  - One subgroup member raised the importance of developing economywide approaches that prioritize the reduction of co-pollutants and greenhouse gas emissions in DACs.
    - Subgroup discussed policy options, including targeting reinvestment in DACs, focusing on sectors causing co-pollutant emissions, and incorporating co-pollutant reduction in a clean energy supply standard.
    - Subgroup emphasized the need to prioritize co-pollutant reduction with any economywide approach.
- Review of Criteria List from Draft Scoping Plan and Matrix
  - o Criteria list as a whole
    - Majority of subgroup members indicated they're generally comfortable with the current criteria list as a whole.
  - Emissions Criteria
    - Subgroup members indicated they're largely comfortable with the current criteria list under this category.
      - One member noted that in addition to GHG emissions, co-pollutants should also be considered in the economywide strategy.
  - o Economic Criteria
    - Subgroup members had mixed levels of comfortability with the current criteria list under this category.
    - Subgroup members recommended clarifying language, specifically on criteria "supporting economic development" and that low-carbon economic development could benefit from clarification.
      - Subgroup members emphasized importance of maintaining existing economic development and state competitiveness.
      - One subgroup member suggested adding emphasis on the economic benefits secured by recommendations in the Scoping Plan.
  - o Equity Criteria
    - Subgroup members indicated they're largely comfortable with the current criteria list under this category but noted some redundancy in one of the criteria.
    - Subgroup members identified "prioritizing emissions reductions and avoiding hotspots in DACs" and "affordability and avoiding regressive impacts" as priority criteria.
  - Programmatic Criteria
    - Subgroup members have mixed comfortability with the current criteria list under this category.

 Subgroup members requested consideration of adding administrative complexity and/or ease of implementation as an additional criterion.

## Key Takeaways:

- There was strong interest in prioritizing all criteria categories and will influence the ordering of future meeting discussion topics.
- Research other jurisdictions' consideration of a clean energy supply standard for buildings, otherwise referred to as a clean heat standard.
- Explore policies that prioritize co-pollutant reduction in Disadvantaged Communities.
- Economic criteria: refine economic development language to emphasize affordability, competitiveness, and benefits in the Scoping Plan.
- Equity criteria: reduce redundancy and add distinction that might be missing.
- Programmatic criteria: add ease of implementation as a criterion.
